

New Hope Recovery Houses Sobriety Contract

I, _____, hereby agree to the following conditions to live in a New Hope Recovery House:

1. I will not use drugs or alcohol during the duration of my stay New Hope Recovery's house.
2. I will establish a continuing treatment plan with my sponsor/counselor and meet with him/her regularly.
3. I understand that no alcohol and/or drugs are allowed in New Hope Recovery's house, and that it is my responsibility to report any such activity to the house manager immediately.
4. I understand that if drugs and/or alcohol are found in my possession that I will be evicted immediately.
5. I agree to submit to random drug/alcohol screenings.
6. I understand that in the event I fail a screening, I will be evicted immediately.
7. I will attend all required house meetings.
8. I agree to be placed on probation for a minimum of 2 weeks, or for as long as the house manager requires.
9. If working I will attend at least four 12 step or other recovery based groups per week. If not working I will attend a meeting/group each day. I will submit documentation verifying my attendance to the house manager.
10. I will seek my sponsor/counselor's guidance regularly.
11. I understand that the other New Hope Recovery residents are not my primary support system. I also understand that I cannot be the primary support for someone else while I am in recovery and residing at New Hope Recovery's house.
12. I understand that after warnings/writeups for non-alcohol/drug related infractions, including ignoring New Hope Recovery's guidelines, I will be evicted.
13. I understand that grounds for immediate eviction are:
 - a. Stealing
 - b. Breaking curfew or not coming home
 - c. Damage to property
 - d. 3 or more write-ups
 - e. Violence against self or others
 - f. Abuse of any mind or mood altering substance
 - g. Sexual misconduct
 - h. Non-payment of services
 - i. Lying on my application
14. I understand that overnight adult or children guests are not permitted.
15. I agree to maintain regular employment or actively pursue employment.
16. I will pay my rent every week on Fridays. I will pay any late fees accrued if no payment plan is set up with manager. I will pay any fines from write-ups for chores being incomplete.
17. I understand New Hope Recovery is not responsible for lost or stolen personal items/money.

18. I will comply with New Hope Recovery's curfew of 10:30pm from Sunday thru Thursday, and 1:30am on Friday and Saturday while on probation. When off probation I will comply with the daily curfew of 1:30am.
19. I will refrain from malicious gossip and verbal abuse of my fellow New Hope Recovery residents.
20. I will respect the property of all household members, and will not engage in violent behavior.
21. I will not smoke inside the residence of New Hope Recovery. I will not use candles or incense.
22. I agree that if I am asked to do a chore, I will complete it the same day.
23. I acknowledge the below signing of this contract signifies that I have read, understand, and agree to the terms of my contract with New Hope Recovery's house.
24. I understand that violation of this contract may result in a write-up or eviction.
